The Cedar Creek Battlefield Foundation welcomes you to apply to join us for the 157th Anniversary Reenactment of The Battle of Cedar Creek on October 15-17, 2021. Please read the following guidelines and conditions carefully before submitting your application.

- Strive for authenticity.
- Please provide an up-to-date general listing of your merchandise or offerings. The sale of homemade food items is prohibited.
- Only white canvas tents allowed. Absolutely no modern camping.
- All tents must be equipped with fire extinguishers.
- Set up time begins at 10:00 A.M., Wednesday, October 13th. No prior entrance will be allowed. Vehicles parked on the main field will remain in place beginning Friday evening.
- No parking of trailers or motor vehicles on sutlers row after set-up.
- All sutlers must set-up on Sutlers Row in the area provided. Shop area will be strictly held to the size indicated. The sharing of spaces is not allowed.
- Children must remain with their parents or sponsors. CCBF will not be responsible for unattended minors.
- Participant passes will be limited to four (4) per sutlery.
- No pets allowed on the grounds.
- CCBF assumes no responsibility for weather and/or ground conditions, or any COVID related business operating restrictions.
- Before departure on Sunday, sutler areas must be cleared of trash and returned to a natural landscape.
- Sutler fees are composed of a base fee plus a calculation of ten cents per square foot.

Violations of these guidelines subject individuals and/or their business to corrective action at the discretion of CCBF.

All applicants are subject to approval by the Cedar Creek Battlefield Foundation based on predetermined criteria, which includes dedication to historical authenticity, space availability, and ability to adhere to the above guidelines.
